**RESOLUTION**

1 A RESOLUTION concerning

2 Car Free Car Day

3 For the purpose of expressing the County Council's support for declaring September 22, 2010 as  
 4 Car Free Day in Prince George's County as part of international mobility week in the  
 5 Washington, D.C. metropolitan region.

6 WHEREAS, the National Capital Region Transportation Planning Board (TPB) is the  
 7 metropolitan planning organization for the Washington, D.C. metropolitan region; and

8 WHEREAS, the TPB, through its Commuter Connections program, promotes and organizes  
 9 the annual Car Free Day event throughout the Washington D.C. metropolitan area; and

10 WHEREAS, on July 21, 2010 the TPB approved a resolution proclaiming September 22,  
 11 2010 as Car Free Day in the metropolitan Washington, D.C. area and encouraged TPB member  
 12 jurisdictions to adopt similar resolutions; and

13 WHEREAS, Car Free Day encourages Washington, D.C. metropolitan area residents to use  
 14 alternative forms of transportation, including public transit, bicycling, walking and "car lite"  
 15 methods, such as teleworking and carpools by making a public pledge at  
 16 [www.carfreemetrodc.com](http://www.carfreemetrodc.com); and

17 WHEREAS, Car Free Day is part of the international mobility week, occurring during the  
 18 week of September 16 – 22, 2010; and

19 WHEREAS, Car Free Day is now celebrated in 1,500 cities and counties in 40 countries;  
 20 and

21 WHEREAS, Prince George's County Council is committed to promoting improved air  
 22 quality, reduced traffic congestion, conservation of energy and the use of transportation

1 alternatives in the County and Region.

2 THEREFORE LET IT BE RESOLVED, the County Council of Prince George's County,  
3 Maryland, hereby supports and proclaims September 22<sup>nd</sup> as Car Free Day in Prince George's  
4 County.

5 BE IT FURTHER RESOLVED that all residents of the County are encouraged to use  
6 public transit, bicycling, walking, and care lite methods, such as teleworking and carpooling, on  
7 September 22<sup>nd</sup>.

8 BE IT FURTHER RESOLVED that copies of this Resolution be sent by the Clerk of the  
9 Council to the Metropolitan Washington Council of Governments and the National Capital  
10 Region Transportation Planning Board.
